Keep Your Child On Track in Middle and High School: Pay Attention to Attendance

Showing up for school has a huge impact on a student's academic success. Even as children grow older and more independent, families play a key role in making sure students get to school every day and understand why attendance is so important for success in school and on the job.

DID YOU KNOW?

- Students should miss no more than 9 days of school each year to stay engaged, successful and on track to graduation. Frequent absences can be a sign that a student is losing interest in school, struggling with school work, dealing with a bully or facing some other difficulty.
- By 6th grade, absenteeism is one of three signs that a student may drop out of high school.
- By 9th grade, attendance is a better predictor of graduation rates than 8th grade test scores.
- Missing 10%, or 2 days a month, over the course of the school year, can affect a student's academic success.

WHAT YOU CAN DO

Make school attendance a priority

- Talk about the importance of showing up to school every day.
- Help your children maintain daily routines, such as finishing homework and getting a good night's sleep.
- Try not to schedule dental and non-urgent related medical appointments during the school day.
- Keep your student healthy, and if you are concerned about Covid-19, call your school for advice.
- If your children must stay home because they are sick, make sure they have asked teachers for resources and materials to make up for the missed learning time in the classroom.

Help your teen stay engaged

- Find out if your children feel engaged by their classes, and feel safe from bullies and other threats.
- Make sure your teens are not missing class because of challenges with behavioral issues or school discipline policies. If any of these are problems, contact the school and work with them to find a solution.
- Monitor you teen's academic progress and seek help from teachers or tutors when necessary. Make sure teachers know how to contact you.
- Stay on top of your child's social contacts. Peer pressure can lead to skipping school, while students without many friends can feel isolated.
- Encourage your child to join meaningful after-school activities, including sports and clubs.
- Notice and support your students if they are showing signs of anxiety.

Communicate with the school

- Know the school's attendance policy incentives and penalties.
- Check on your child's attendance to be sure absences are not adding up.
- Seek help from school staff, other parents, or community agencies if you need support.



Dear Parents/Guardians,

Since implementing a more uniform cell phone policy/limits for our Grade 8s in August, 2023, we've had feedback from staff, parents, and even students, that this is working well and has been a welcome change for our school community.

This is a reminder that we will continue to implement a no cell phones in class guideline for all Grade 8 classes. Students will "park" their phones in cell phone "parking lots" provided by us at the beginning of class and will pick them up at the end of class. They will still have access before class, at breaks, and lunch times. For your information, our classes are approximately 80 minutes in length.

If there is a family emergency when your child does not have access to their phone, please reach out to our main office at 667-8044 and we'll call down to the classroom.

Please note: if your child needs access to their cell phone for a medical reason (such as to monitor their blood sugar for a child with diabetes), please contact me or a Vice Principal to let us know and we will note this for their teachers.

Dear Parent/Guardian:

Because emergencies can occur which require us to evacuate the school, we want to remind you that, in the case of such an event occurring: the following procedures will be in place:

IN CASE WE NEED TO EVACUATE PCSS IN AN EMERGENCY, OUR ALTERNATE SITE IS JACK HULLAND SCHOOL.

We are prepared to care for students in the case of a critical situation, or if parents/guardians are not able to reach the school or alternate site. We have a number of people with first aid certificates, and we will be in a communication with local emergency services. Our school is equipped with emergency supplies that will allow us to tend to our students.

We do ask you to help in the following areas:

*turn your radio to one of these FM stations: CBC (94.5), CKRW (91.5) or CHON (98.1) – information / direction will be given over the radio; *please do not call the school; lines must be open for emergency calls;

*following an earthquake or other city-wide emergency, do not immediately drive to the school; streets and access to our school may be cluttered with debris and the school access route must remain clear for emergency vehicles.

PLEASE keep this letter in a safe place so you may easily refer to it in the case of an emergency.

Re: Yukon Threat Assessment Program

Dear Parents/Guardians:

The safety of our children is a top priority for everyone. The tragedies that have occurred where students commit violent acts against other students and educators in Canada and in the United States have caused government officials, educators, parents, students and other community members to assess how we make our schools and communities safe for our children and students.

Public Schools Branch staff members have been involved in an intensive safety training program with our community partners, the Royal Canadian Mounted Police, Yukon Department of Health and Social Services, and Yukon Department of Justice. From what we have learned in this training we know that student acts of violence are not random; individuals do not suddenly snap and commit serious acts of violence. In cases where serious acts of violence have occurred there have been many indicators and escalating signs that these individuals are on a path to commit serious harm to themselves or others. The training has helped our professionals to recognize these signs, assess them, and put in place interventions to support and reduce the level of risk. Together with our community partners, Public Schools Branch has developed a plan to respond to situations in which students may be demonstrating behaviours that pose a risk to themselves or others.

We wish to advise parents that we have adopted a policy which requires schools to undertake a Threat Assessment in all cases of students making threats to harm themselves or others. These threats may be physical, verbal or written; they may be gestures or messages posted on the Internet. The purpose of the Yukon Threat Assessment Program is to determine how best to support students considered at risk so that their behaviour does not become hurtful or destructive to themselves or others.

Parents can play an active role in keeping our schools safe by advising the school of any information communicated to them from their children concerning threatening behaviours that their children may have been subjected to, in or out of school, and continuously monitoring their children's use of the Internet and Internet chat lines.

This letter is intended to provide you with fair notice that all Yukon schools will respond to all threats in a professional manner that provides for safe, healthy, and caring learning environments. Any threats or threat making behaviours will be taken seriously and assessed accordingly. Parents will be informed if their child is part of a threat assessment.

We are pleased to be able to provide this level of support to our school communities and appreciate having the ongoing support of our community partners.

Video Surveillance Policy

All information obtained by video surveillance is confidential and will only be transmitted to Education or police authorities when criminal or other illegal acts are suspected.

All recorded information will be destroyed within 30 days of being recorded unless they are used as part of an investigation.

Any personal information collected through the use of the Video Surveillance Cameras at this site is collected and managed under the authority of s. 29(c) of the Access to Information and Protection of Privacy Act (ATIPP) and s.6(1)(h) of the Education Act.
